# **Chair's Viewpoint**

This is my last opportunity to provide a Chair's update as I will be standing down at the AGM on June 13th. I would like to remind you of the commitments I made at the beginning of my year and to comment on SDA's progress since then.

I said in Saintfield News edition 8 that my priority was to ensure that all political parties and new directors in the NMD Council came to understand the needs of Saintfield and to build the partnership between SDA and NMD. I said that the test of this would be the progress made with the new community centre and with working with the sports clubs in Saintfield and Darragh Cross to improve our outdoor sports facilities.

I am pleased to say that we have made very good progress in building relationships with councillors and officials in the new Council. We have met all political parties in NMD and had productive meetings with all relevant senior officials. I believe that the significant progress on the community centre (reported elsewhere in this issue) has been largely due to these strengthened relationships and I would like to commend all those on the SDA community centre team for their hard work and perseverance in bringing this

about.

The new Council has set up a "DEA Forum" for each of its District Electoral Areas. Community Groups were invited to apply to join these and I am pleased to advise that the SDA has been selected to join the Rowallane DEA Forum. The first meeting of this Forum was held on 8th June and it should provide better communications between the NMD and all community groups in our local area.

Progress to improve outdoor sports facilities has not happened as hoped as Sport NI applied restrictions to its new funding stream that effectively ruled Saintfield and Darragh Cross ineligible to apply.

Finally I would like to

congratulate the chairs and members of the SDA committees who have made so much happen during the year.

Lawrence Murphy, as well as being treasurer, is the chair of the Green/Saintfield in Bloom 365 Committee, wining awards yet again for their floral displays and litter picks; Bob Pollock and the Events Committee organised an excellent Christmas Fair and very popular cycle runs: Barbara Graham and the Infrastructure Committee led the progress for the community centre; Brian Gamble and the **Communications** Committee produced Saintfield News and various press releases, lan Mack, as well as being secretary also kept the website up to date and circulated electronic newsletters, while David Greer managed the SDA Facebook page. Paul McGeown, as Vice-Chair, gave me excellent advice and support throughout the year.

## **Community Litter Pick**

The Green committee of the SDA organised a successful community litter pick on Saturday 14th May. A total of 28 people took part, including eight pupils and a teacher from Academy school, which was good to see.

In the space of two or three hours, the team of volunteers cleaned up 13 roads, a wood, three car parking areas, two play parks, two sports grounds and about 4 km of streets. The end result was 28 bags of rubbish, of which four bags

The broad plan is as follows.

#### **Building A**

As proposed at the public meeting ,this will be an indoor space for large ball sports with a "4G" or similar surface and adjoining storage and changing facilities.



"Active Saintfield" is a group of our sports club leaders chaired by David Morrow.

They have volunteered to form a trust to administer this facility.

#### **Building B**

The idea is that this will be the hub of the Community facilities.

These will be guided by the results of the

questionnaire we carried out two years ago.

They include a multi purpose hall and both a small and large club / meeting room.



We also would like to include an adjoining small closed off outside space and a generous lobby / social space which would be common to all and form the approach to all the different spaces.

#### **Building C**

This will be largely the space for Leisure facilities, exercise classes, children's party

facilities etc and we expect this to be the focus of the private partner. It may be they charge a membership fee similar to most leisure facilities.

#### The Way Forward

At this stage we feel that we need to obtain more detailed feedback from end users. We need to know how you would use the community space e.g. what size of hall you would need.

We are conscious that we need to be very clear about what we want and why, otherwise we will have something imposed on us which may not be suitable or meet the needs of the community.

#### Governance

Council have proposed that the whole facility be overseen and governed by a Trust composed of local end users and Council representatives.

The advantage of this for us is that we will have a say in how the facilities are run and can design this to suit our needs. It does, however focus minds on providing facilities which are well thought out and fit our needs without being excessive, impractical or uneconomic.

#### **Private Partner**

We also need to be conscious of a very tight budget. A private partner will take responsibility for the day to day running of the facility, so there would be no caretaking duties required from us.

The Saintfield Development Association cannot be the sole local member of this trust. The trust must have members representative of end users.

We need those who see themselves as regular users to contact us so that we can get together and develop a better idea of who should be involved in the Trust.

#### **Open Day**

We are planning to hold an open day at the site in early September. The idea is to let Saintfield people tour the site and get an idea of the size of the buildings and how we hope to use them.

We envisage that this would be a fun day with play equipment for children, food stalls etc.

We thought clubs might like to put up stalls showcasing themselves and attract potential members.

#### Finally

We would appreciate your attention and help with this major project, which has taken so much time, effort and negotiation to reach this stage.

The finishing line is in sight and we just need to make the final push to achieve our goal – a well designed and useful facility to serve the needs of all sections of the Saintfield and district community.

# "Grow Wild" In Saintfield

The Green committee of the SDA has been busy developing the ground at two sites in Saintfield as part of the "Grow Wild" nationwide campaign.

Grow Wild is the U.K.'s biggest ever wild flower campaign, bringing people together to transform local spaces with native, pollinator friendly wild flowers and plants,

The areas selected in Saintfield are the Points at the junctions of Belfast and Comber roads, and Lisburn and Old Belfast roads. Committee members, with the help of volunteers and three pupils and a teacher each from St. Mary's

Primary and Saintfield High, prepared the ground, seeded it with grass and planted a variety of wild flowers.

The wild flower sites will need constant watering during the summer months and their displays will do much to enhance the appearance of the roads into Saintfield and further improve the image of the village.

All the work has been done by volunteers, with machinery and materials donated by local people and it is hoped that their efforts will be appreciated by residents and the sites left alone to mature.



### Saintfield Crime Report

There were 29 crimes reported in the Saintfield area for the month of March 2016, the latest figures available from the PSNI. This is a significant increase on the five incidents reported in January and the six in February.

Anti social behaviour once again tops the table with a total of 10 offences reported in March. This figure does not reflect the probable scale of the problem as by the very nature of the offence, many instances may go unreported.

There was a spate of burglaries, with six crimes reported, followed by five offences of violence or sexual violence. There were two drug offences, two vehicle crimes, two thefts and one report each of criminal damage and shoplifting.

Saintfield residents and businesses need to be more aware of the threat posed by criminals and hooligans and to be more security conscious.


# Waste Ground Developed
